About Okayama Law

Undergraduate Program

The aim of our undergraduate education is to cultivate students' legal mind, ability to look into current social issues from various perspectives, and communicative competence to survive in a globalized world. The faculty provides seminars on a variety of subjects throughout the four years of study in order to nurture students' independence.

First-year students take introductory courses in law and politics along with liberal arts subjects offered by other departments. In the second year, students start learning fundamental subjects of law such as Constitutional Law, Criminal Law, and Civil Law.


Third- and fourth-year students study along one of three tracks. Students preparing for a future career as civil servants or in the world of politics choose the Public Law and Policy track and study Public Policy, Administrative Law, Tax Law and related topics. The Business Law track offers an opportunity to go into advanced legal subjects relating to business activities such as Company Law, Law of Business Transactions, Labor Law and Competition Law. The Legal Services track targets students who aim to pursue a career in the legal profession or other paralegal services. Civil Procedure Law and Criminal Procedure Law are its core subjects. All third- and fourth-year students are encouraged to take courses relating to international legal and/or political issues.

International Exchange

Law students can join the international exchange program offered by Okayama University (EPOK: Exchange Program Okayama). Students interested in an international career can enroll in the special program provided by the Institute of Global Human Resource Development of Okayama University, where the students are required to take academic English courses and courses taught in English, and to take part in overseas study tours. Each year, several law students study at some of the overseas universities having an exchange agreement with Okayama University, among which are the University of Kent (UK), California State University at Monterey Bay (U.S.), Bishop's University (Canada), and the University of South Australia (AU), Jilin University (China), Sungkyunkwan University (South Korea).

Graduate Studies

Students can continue studying law or politics in the Graduate School of Humanities and Social Sciences where faculty staff provide courses as members of the School, or continue studying in our School of Law to become a lawyer.



Research

 Collaboration of Fundamental and Clinical Studies

The Faculty of Law has been prominent in the areas of fundamental jurisprudence as well as interdisciplinary, comparative studies of law and politics. In recent years, this academic strength of our faculty has been reinforced by the frontline work of younger members distinguished in empirical and clinical studies. Many faculty members are engaged in joint research projects with municipal governments as well as the legal profession in Okayama, which has created a larger intellectual community of academics, practitioners, and citizens. Through its faculty-run publication, *Okayama Law Journal*, founded in 1951, we publish recent research results and new theoretical and policy proposals.

- ◆ Workshop on Fundamental Jurisprudence develops research agendas on historical studies of legal principles and institutions, philosophy of law, and socio-legal theories.
- ♦ Workshops on Public Law and Private Law serve as intellectual communities in the region through which professors, judges, lawyers and graduate students collaboratively study the current issues on Constitutional Law, Administrative Law, Property Law, Contract Law, Business Law, Tax Law and other areas.
- Workshop on Law-related Education is the regional center and joint effort of our faculty and the Okayama Bar Association for teaching citizens basic ideas of law and politics.
