### **【Submission of Income and Taxation Certificates】**

Certificate of Income and Taxation for 2025(FY2026) will be issued by the municipal (city/ward/town/village) government

Applicants are encouraged to submit the certificate by the deadline with submitter list (**Yellow Paper**).

### **【Note】**

#### ①【 Certificate of Income and Taxation for 2025 (Fiscal Year 2026) 】

The amount on the certificate of Fiscal Year 2026 ought to correspond to the amounts recorded on the document attached to the application form withheld tax slip, the salary payment certificate, and the final tax returns book of 2025, etc...

- ② If the certificate is not submitted, your application may be excluded from the selection process due to insufficiency of documentation.
- ③ Certificate of Income and Taxation should be copied before submission and you should keep it.

\* **Different municipal offices will start the issuance of Certificate of Income and Taxation at different timings; you are advised to confirm the timing in advance so as not to miss the submission deadline.**

\* **In cases where you cannot meet the above submission deadline because your municipal office will begin to issue the certificates immediately before or after the deadline, please notify in advance student support division about your delayed submission.**

**Notice (to be confirmed before submission)**

- ◆ Before submitting, please be sure to check the Certificate of Income and Taxation notes on page 8-9 of Application guideline.
- ◆ Please note that failure to submit any additional or resubmitted required documents by the specified deadline will result in exclusion from the selection process.
- ◆ Please read the Notes on the backside carefully. Be sure to notify us if anything has changed regarding the situation described on the Application form.
- ◆ The original of the Certificate on Income and Taxation must be submitted (Photocopies are not acceptable.); therefore, take a photocopy before submission and keep it on your own.

### <The selection results of tuition fee exemption and tuition payment>

Due to the short period of time between the notification of selection results and the deadline for payment, please pay close attention to the deadline for tuition payment.

## 授業料免除申請書類の提出後の **注意事項**

**Notes** after your submission of application for tuition fee exemption.

### 1 **注意事項 Notes**

- 申請書提出後、前半期分授業料免除申請では4月1日時点（後半期分授業料免除申請では10月1日時点）の状況に変化があった場合は、速やかに申し出て申請内容の訂正をしてください。（例えば、転居や新しいアルバイトを始めた場合など）

※ 未申告の内容が判明した場合等には、申請取り消しとなることがあります。

- 本学職員の指定する期限までに追加書類提出が完了しない場合は、選考の対象から除外します。
- 選考結果が決定する前までに休学や退学をする場合は、速やかに申し出てください。

- After submission, if your situation, such as address or employment, has changed as of April 1st for the First Semester (as of October 1st for the Second Semester), you must visit the office to update your status as soon as possible. (e.g. Started new part-time job, Moved and changing of address.)

※ The applications with a false report, errors and illegible or incomplete preparing requested forms or documents will be excluded from the selection process and not be considered.

- Applicant who do not complete the submission of additional documents by the deadline specified by university will be excluded from the selection process.
- In the case of temporary absence from school or withdrawal from school before the determination of tuition fee exemption, contact the relevant office as early as possible.

- 提出された書類等は、返却、貸出及び閲覧ができません。  
授業料免除申請で提出する全ての書類は、提出前に必ずコピーを取っておいてください。

- Once submitted documents cannot be returned, lent for making photocopies, or examined again. All documents should be made photocopies before your submission.

- 免除申請に関する連絡は、大学が付与しているGメールアドレス宛に連絡しますので、普段使用しているメールアドレスに転送する等の設定をし、必ず受信できるようにしておいてください。不足書類に関する連絡が取れない場合や、指定された期限までに書類の提出ができない場合は、選考の対象から除外します。

- All communications regarding exemption applications will be sent to the Gmail address provided by the university. Please ensure that you can receive these emails by setting up email forwarding to your primary address or taking other necessary steps. **In case of contact unavailable or incomplete matters have not corrected by the deadline, your application will be excluded from the selection process.**

### 2 **申請結果の決定の時期 Scheduled date of decision on application results**

前半期分授業料免除申請：7月下旬（予定） [後半期分授業料免除申請：1月下旬から2月上旬（予定）]

First Semester : Late-July (scheduled) [Second Semester : Late-January to early February (scheduled)]

免除申請の結果が決定するまでは、授業料の納入は猶与されます。

免除申請結果の通知は、郵送により申請者本人あてに送付します。

半額免除 及び 不許可の場合は、該当の授業料を指定された期限までに納入してください。

Applicants for tuition fee exemption are granted a grace period for their tuition fee payment until they receive notification of the result of their applications.

Notification letter of the results of the application will be sent to the applicant by mail. Applicants must pay the designated tuition fee within the required period other than those who are fully exempted from tuition fee.
